I. Length of Authorization

Coverage will be provided for 6 months and may be renewed.

II. Dosing Limits

A. Quantity Limit (max daily dose) [NDC Unit]:

- 4 mg single-dose vial for injection: 2 vials every 21 days

B. Max Units (per dose and over time) [HCPCS Unit]:

- 80 billable units every 21 days

III. Initial Approval Criteria ¹

Coverage is provided in the following conditions:

- Patient is at least 18 years of age; **AND**

Universal Criteria ¹

- Used as a single agent; **AND**

Small Cell Lung Cancer † ‡ Φ ¹⁻⁴

- Used for metastatic disease after disease progression on or after platinum-based chemotherapy (i.e., cisplatin, carboplatin) †; **OR**
- Used as subsequent therapy for relapsed or primary progressive disease ‡

† FDA Approved Indication(s); ‡ Compendia Recommended Indication(s); Φ Orphan Drug

IV. Renewal Criteria ¹

Coverage may be renewed based on the following criteria:

- Patient continues to meet the universal and other indication-specific relevant criteria such as concomitant therapy requirements (not including prerequisite therapy), performance status, etc. identified in section III; **AND**

- Disease response with treatment as defined by stabilization of disease or decrease in size of tumor or tumor spread; **AND**
- Absence of unacceptable toxicity from the drug. Examples of unacceptable toxicity include: myelosuppression (e.g., neutropenia, thrombocytopenia, anemia, etc.), hepatotoxicity, extravasation resulting in tissue necrosis, rhabdomyolysis, etc.

V. Dosage/Administration ¹

| Indication | Dose |
|------------------------|--|
| Small Cell Lung Cancer | Administer 3.2 mg/m ² by intravenous infusion every 21 days until disease progression or unacceptable toxicity. |
