I. Length of Authorization

Coverage will be provided for 6 months and may be renewed.

II. Dosing Limits

- A. Quantity Limit (max daily dose) [NDC Unit]:
 - Portrazza 800mg/50mL single-dose vial: 2 vials every 21 days
- B. Max Units (per dose and over time) [HCPCS Unit]:
 - 800 billable units Day 1 and 8 every 21 days

III. Initial Approval Criteria 1

Coverage is provided in the following conditions:

• Patient is at least 18 years of age; **AND**

Non-Small Cell Lung Cancer (NSCLC) 1-3,1e,2e †

- Used as first-line therapy for metastatic disease; **AND**
- Disease has squamous cell histology; AND
- Used in combination with <u>BOTH</u> gemcitabine and cisplatin; **AND**
- Use of necitumumab as first-line therapy will be restricted to patients with a contraindication or intolerance to a generically available regimen (e.g., carboplatin/docetaxel, etc. [see NCCN NSCLC guidelines for complete list of alternative regimens])

Preferred therapies and recommendations are determined by review of clinical evidence. NCCN category of recommendation is taken into account as a component of this review.



Regimens deemed equally efficacious (i.e., those having the same NCCN categorization) are considered to be therapeutically equivalent.

IV. Renewal Criteria 1

Coverage can be renewed based upon the following criteria:

- Patient continues to meet indication-specific relevant criteria such as concomitant therapy requirements (not including prerequisite therapy), performance status, etc. identified in section III; AND
- Disease response with treatment as defined by stabilization of disease or decrease in size of tumor or tumor spread; AND
- Absence of unacceptable toxicity from the drug. Examples of unacceptable toxicity include: cardiopulmonary arrest, hypomagnesemia, severe dermatologic toxicity, severe infusion reactions, and venous/arterial thromboembolic events, etc.

Indication	Dose
Squamous Cell NSCLC	Administer 800 mg intravenously on Days 1 and 8 of each 3-week cycle prior to gemcitabine and cisplatin infusion. Continue until disease progression or unacceptable toxicity.
