I. Length of Authorization ⁶

Coverage will be provided for 6 months and may be renewed.

II. Dosing Limits

- A. Quantity Limit (max daily dose) [NDC Unit]:
 - Tevimbra 100 mg/10 mL single-dose vial: 2 vials per 3 weeks
- B. Max Units (per dose and over time) [HCPCS Unit]:
 - ESCC: 200 mg every 3 weeks

III. Initial Approval Criteria ¹

Coverage is provided in the following conditions:

Patient is at least 18 years of age; AND

Universal Criteria

• Patient has not received previous therapy with a programmed death (PD-1/PD-L1)-directed therapy (e.g., nivolumab, pembrolizumab, atezolizumab, avelumab, cemiplimab, dostarlimab, nivolumab/relatlimab, retifanlimab, toripalimab, durvalumab, etc.), unless otherwise specified ^{\(\Delta\)}; **AND**

Esophageal Squamous Cell Carcinoma (ESCC) † 1-3

- Used as single-agent therapy; AND
- Patient has unresectable or metastatic disease; AND
- Used as subsequent therapy after progression on initial chemotherapy

IV. Renewal Criteria ⁶ 1,3

Coverage may be renewed based upon the following criteria:

- Patient continues to meet the universal and other indication-specific relevant criteria identified in section III; **AND**
- Disease response with treatment as defined by stabilization of disease or decrease in size of tumor or tumor spread; **AND**
- Absence of unacceptable toxicity from the drug. Examples of unacceptable toxicity include: severe or life-threatening infusion-related reactions, immune-mediated adverse reactions (e.g., pneumonitis, hepatitis, colitis, endocrinopathies, nephritis with renal dysfunction, dermatology reactions, pancreatitis, etc.), complications of allogeneic hematopoietic stem cell transplantation (HCST), etc.

[∆] Notes:

- Patients responding to therapy who relapse ≥ 6 months after discontinuation due to duration are eligible to re-initiate PD-directed therapy.
- Patients previously presenting with aggressive disease who are exhibiting stable disease on treatment as their best response (or if therapy improved performance status) may be eligible for continued therapy without interruption or discontinuation.
- Patients who complete adjuvant therapy and progress ≥ 6 months after discontinuation are eligible to re-initiate PD-directed therapy for metastatic disease.
- Patients whose tumors, upon re-biopsy, demonstrate a change in actionable mutation (e.g., MSS initial biopsy; MSI-H subsequent biopsy) may be eligible to re-initiate PD-directed therapy and will be evaluated on a case-by-case basis.

Esophageal Squamous	Administer 200 mg intravenously once every 3 weeks, until disease progression or
Cell Cancer	unacceptable toxicity.
